# REPORT OF TWO DAY NATIONAL CONFERENCE ON "HIGHER EDUCATION IN INDIA- DEVELOPING EMPLOYABILITY AND ENTREPRENEURSHIP"

Gokhale Education Society's Shri B.V Arts, Commerce and Science College, Borivali (W), Mumbai-91 organized 27th Annual Conference of Maharashtra Council of Education Administration and Management (MCEAM), Pune in collaboration with Dr. M.S.G. Foundation, Mumbai on 14th and 15th February, 2020. The theme of the Conference was" Higher Education in India- Developing Employability and Entrepreneurship".

Total 60 articles were received for this conference and all the articles have covered the different dimensions of theme and are classified accordingly.

## INAUGURAL SESSION:

The Two Day National conference began with seeking the blessings of the almighty by lighting the lamp. After the invocation, the Principal and Conference Secretary Dr. (Mrs.) S. V. Sant, introduced and welcomed the Chief Guest Dr Bhalchandra Mungekar, former vice-chancellor, University of Mumbai and the Guest of Honour CA Prakash G. Referring to the Shultz theory of investment in human capital, Dr. Mungekar stated that the inadequate provision for education was the main reason for the abysmal quality of education. According to him, education should be top priority and not be considered non-productive expenditure.

In his Presidential address Sir Dr. M.S. Gosavi, President, MCEAM, Pune, appreciated the opposing views of the previous speakers, who he said had set the perfect ambience for a fruitful discussion during the conference. He traced the history of institutional learning of Ancient India with world-class Universities of Nalanda and Takshila and Scholars such as Panini and Kautilya. He pointed out the decline of the present day education system and termed it ineffective and meaningless.

The dignitaries were then escorted by Principal Dr. Mrs. S.V.Sant, to visit the exhibition arranged by Shri Bhausaheb Vartak College on the completion of hundred years of Gokhale Education Society. Principal Dr. T.A. Shiware, Director, Wilson College was a chief guest for the exhibition.

#### REPORT OF TECHNICAL SESSION- I

The sub-theme of Technical Session- I was Future Jobs and Higher Education. Chairman of the session was Dr. M. S. Kurhade, Director, Sanskar Sarjan Education Society, and Dr S. P Kallurkar, Prin. Atharva College of Engineering, Mumbai was a keynote speaker. Drs Mrs S. V Sant and Dr. Mrs. S. N. Khedekar presented the papers.

#### CULTURAL PROGRAMME


